1 Silas DEACON (1788-1877) [8].

Born 1788, Stalbridge, Dorset, England. Died 1877, Bruton, Somerset.¹ It is possible that his estimated age at death was overstated by ten years. Buried 12 Jun 1877, Bruton, Somerset.

Searches on FamilySearch.org and Ancestry.com failed to produce details of Silas & Elizabeth's marriage.

Sp. Elizabeth DIBBLE (1803?-1888?) [9].

Born 1803 (cal), Stowey, Somerset.^{2,3} Her estimated age at death suggests her birth year was about 1807 but her age given in the four censuses 1851 to 1881 all suggest her birth year was 1803 or 1804. Died 1888 (app), Wincanton, Somerset.⁴ Her age at death appears to have been underestimated.

1.1 Hester DEACON (1824?-1852) [52].

Not found in 1861 or subsequent census. There is a death registration for Silas James Deacon in 1856 at Clifton, Gloucestershire (ref: Dec qtr 1856, Clifton, Vol 6a; page 65).

1.3 Harriett DEACON (1832?-) [54].

Born 1832 (cal), Stowey, Somerset.⁵ Marr John KEMP 1870 (app), Westbury, Wiltshire.⁷

Not found in 1891 or subsequent census. Registration of death not identified in BMD Index.

Born 1816 (cal), Melksham, Wiltshire.⁸ Died 1890 (app), Melksham, Wiltshire.⁹ Age at death may have been overestimated.
